

# Clause List of Scholarship Program for Foreign Students at NTUT

July 5<sup>th</sup>, 1995, approved by the Executive Convention

Clause #1 : The scholarship program—on the basis of “Appropriation Regulations for Foreign Students at Colleges & Universities and Their Subsidiary Units Funded by the Ministry of Education”—is exclusively applied to NTUT foreign students who have achieved outstanding academic performance and set a good example in moral disciplines. The scholarship program is also considered as part of the approaches by NTUT for making the University more academically internationalized and recruiting better international students.

## Clause #2: Qualification

The foreign students who get officially registered at NTUT (overseas Chinese students not included) may apply if they satisfy any one of the following conditions:

1. The undergraduate students who have finished at least one semester at NTUT, with average 70 above on the academic grade report and 80 above on the Conduct grade report without being punished more seriously than with an Admonition or who are actually justified as financially difficult;
2. Those students in Master or Ph.D programs who have finished at least one semester at NTUT, with average 80 above on the academic grade report and 80 above on the Conduct grade report without being punished more seriously than with an Admonition or who are actually justified as financially difficult.
3. Those students in Master or Ph.D programs who are working on their respective thesis and dissertation writing and are thereafter given no academic grades on the academic report. They are supposed to offer Recommendation Letters from the advisors and thesis/dissertation proposals (in which the following items should be stated in more than 5,000 words: Motivation, Research Structure, Data Sources, Thesis/Dissertation Outlines, Reference...) to apply. The scholarship granted in this category should be applied for no more than once.
4. Those students who preside over the foreign student associations/extracurricular clubs at NTUT, with average 70 above on

the undergraduate academic grade report or 75 above on the graduate academic grade report; if applying in this category, the applicants ought to present related activity reports on the way the extracurricular associations/clubs are successfully managed and run. The scholarship granted in this category should be applied for no more than once.

**Clause #3: Scholarship Time Span , Scholarship Amount and Limitation**

All the undergraduate students are eligible to apply for the scholarship for no more than 8 times for the four-year program students and for no more than 4 times for the two-year program students (the students in their extended period of study being excluded the eligibility), while the students in the Master programs should apply no more than 4 times and the Ph.D students should apply no more than 8 times.

Those who have won any scholarships or funds from Taiwan governmental agencies (NSC project allowances considered as an exception) will automatically be excluded for the application of this scholarship.

**Clause #4: Number of Winners & Source of the Scholarship**

1. Number of Winners: The number of the winners from items 1 & 2 of Clause #2 will take up no greater than 50% of the sum total of the foreign students studying in the same academic system but there is no upper limit for the number of those who apply on the basis of financial difficulty ; the number of winners from item 3 will be no greater than 3 in each individual college and that from item 4 will be limited to no more than one.
2. The Scholarship Amount is thus set on the basis of the nationality and economic status pro of the individual foreign countries.
3. Source of the Scholarship: The subsidy from the Ministry of Education.

**Clause #5: Application & Procedures**

All the foreign students interested in the application of the scholarship are required to offer their application to the Office of International Affairs at the same time when they apply for the admission to study at NTUT. The final result of the scholarship application will be announced by the end of June every year. In the first month of each semester, an applicant list is determined by the Office of Academic Affairs (for those qualified in 1 & 2 of Clause #2), NTUT Colleges

(for those qualified in 3 of Clause #2) and the Office of Student Affairs (for those qualified in 4 of Clause #2), which is thus sent to the Section of Extracurricular Activities for further procession.

The applicant list ought to be decided by the Scholarship Committee and then eventually approved by the NTUT President. The Scholarship Committee is made up of Vice President--who also chairs the Committee, Dean of the Academic Affairs, Dean of the Student Affairs, Dean of the General Affairs, Dean of the R&D, Dean of International Affairs, Deans of the NTUT Colleges, and Director of the Accounting Office--with Director of the International Student Section as the executive secretary.

Clause #6: The Clause List will be officially put into effect, as is approved—and further modified--by the Executive Convention.
