MEDICAL TREATMENT

Non-EU citizens are requested to take out private health insurance before leaving their home country and to obtain a consular declaration of its validity for Italy. In order to get the Residence Permit they are in fact required to be in possession of a private Health Insurance for the entire duration of their stay in Italy.

Once in Pavia non-EU students who do not have such a private health insurance policy can enrol with the **National Health Service**. The subscription to the National Health Service offers a much wider range of services than other private insurance Companies. They will be assigned a General Practitioner (Medico di Base) and the costs for medical treatments in general will be cheaper. They will have to pay about € 149,77 for the subscription, the validity of which lasts until **31st December** of the year on which it is subscribed.

Once they have the receipt of the payment they have to go to the Health Local Unit-ASL .

POLICE PROCEDURES

All visiting students coming to Pavia and remain longer than three months **must register with the immigration authorities** as soon as they have an address in Pavia.

Non EU Citizens are required to apply for a study visa prior to leaving. Applications should be made at their nearest Italian Embassy or Consulate. In this case, they might need a letter of acceptance to ask for their visa

Students are invited to start these procedures well in advance their planned visit to Italy. These procedures are subject to change so it is worthwhile telephoning the embassy or checking the website for information before going personally to the visa office.

Once you arrive in Pavia you must report to the immigration authorities within 8 days.

Where you can get all the necessary information regarding the permit of stay application.

It will take several months to get the Permit of stay, but the students will be given a temporary voucher issued by the authorities with the same value of the Permit of stay.

THE TAX CODE -CODICE FISCALE

The Tax Code is needed to get a permit of stay, open a bank account or to get a Sim card for your Mobile Phone. The Tax code is issued by the Ufficio Locale delle Entrate in short time.
