# Guidelines for National Taipei University of Technology Chinese-Proficient Scholarship

# For International Undergraduate Student

First approved at the 5<sup>th</sup> Executive Meeting for the 2<sup>nd</sup> Semester of the Academic Year 2013/5, May 17, 2014

Article I The "Chinese-Proficient Scholarship", hereinafter referred to as "scholarship" has been established to attract outstanding foreign students from every corner of the world who have displayed a distinguished proficiency in the Chinese language to study at National Taipei University of Technology, hereinafter referred to as "Taipei Tech" and to encourage them to maintain good standing in their study and conduct.

## Article II Eligibility:

- A. New students: Foreign students who have registered and studied as a full-time undergraduate degree program student at Taipei Tech who have proven their superior proficiency in the Chinese language. International students must complete the online health questionnaire and the health checkup after enrolling in the school.
- B. Current students: Current undergraduate foreign students of Taipei Tech who have proven their superior proficiency in the Chinese language and have obtained the updated certificate of participation (Overseas Students Safety and Security Seminar) may apply to the scholarship for the following year.

Students who have obtained the TOCFL score when they are attending Taipei Tech and have obtained the updated certificate of participation (Overseas Students Safety and Security Seminar) may also apply.

#### Article III Requirements:

- A. New students must submit one of the following proofs of proficiency in the Chinese language:
  - 1) A proof of a score of B or better on the TOCFL.
  - 2) Other proofs of proficiency in the Chinese language, such as a score of C or better on the SPM in Malaysia or a score of C or better on the Unified Examination Certificate on the Chinese language in Malaysia.
  - 3) Proofs other than the above items should be evaluated using the conversion table published by the Steering Committee for the Test Of Proficiency-Huayu (except the mainland China area), such as Intermediate High or better on the ACTFL in the United States, grade 2 or better on Testing Chinese Proficiency in Japan, or grade C or better on the TECC in Japan.

- B. Current students: A total average of 70 points or higher in academic studies and 80 points or higher in conduct grade in the previous academic year.
- Article IV Reward: Those students who have met the requirements and have been approved will be rewarded with half of their tuition fees for one academic year.

### Article V Application and Evaluation Process:

- A. New students: They are evaluated for the award during their admission application process and rewards start when the start attending the school.
- B. Current students should submit their applications to the Office of International Affairs during the published period in every Spring Semester, attaching their original transcript for all semesters. Students can submit a make-up application at the end of every Fall Semester, the rewards will be half of their tuition fees for one semester, they should submit their applications in the published period, attaching their original transcript for all semesters.
- C. All applications shall be reviewed by the NTUT Scholarship Commission.
- Article VI Quota of scholarship awards: Determined by the NTUT Scholarship Commission.

#### **Article VIIRestrictions**

- A. In the case that any one of the following conditions occur, Taipei Tech shall immediately disqualify the recipient:
  - 1) The recipient suspended or withdraw from their study or be expelled as confirmed by the Office of Academic Affairs. Those who be suspended may reapply in time specified after they have resumed their enrollment in the school.
  - 2) If the recipient has not completed the enrollment process by the deadline.
  - 3) Leave the nation for more than a month while the school is in session.
  - 4) The recipient has broken the law of ROC in a significant manner.
  - 5) The recipient has been given any major demerits.
- B. This scholarship is awarded to undergraduate students up to the senior year. Students extending their schooling may not apply for the award.
- Article VIII This guideline shall go into effect upon approval by the Administrative Council at Executive Meetings. The procedure is the same for any revision or amendment.
